

**DISEASE CONTINGENCY PLAN**

All exhibitors will be expected to comply with the instructions issued by stewards in the event of a suspected or confirmed case of a notifiable disease being found at the show. These instructions will be as set out in the Society's Disease Contingency Plan.

**ISOLATION**

It is the responsibility of exhibitors to ensure that livestock attending the show comply with the current Defra regulations regarding on-farm isolation and standstills.

From 30<sup>th</sup> May 2003, show cattle, sheep and goats will be able to claim an exemption to the 6 day standstill provided that:

- They have been isolated from all other non-show animals on their resident holding in Defra-approved isolation facilities for 6 days before attending the first show.
- They may return to their farm of origin between shows and move to a further show within 6 days provided that they are kept in approved isolation facilities on the farm
- On final return to the farm, they must be kept in approved isolation facilities for 6 days, or trigger a 6 day standstill on that holding.
- An entire holding may be approved as an isolation facility if it is a single parcel of land which meets the separation criteria.
- They are individually identified.

Cattle, sheep and goats going to shows from a premise where no suitable isolation facilities exist will have to:

- Observe a 6 day whole farm standstill before they go to the first show
- Trigger a 6 day standstill on the whole farm when they return from any show
- Be individually identified
- They may return to their farm of origin between shows and move to a further show after 6 days provided that there are no other movements onto the holding concerned.

**ENTRY CLOSING DATE**

All entries to be made on this form, by Monday 20<sup>th</sup> July 2009.

Including entries for the Semex Calf Handling Classes – for which no entries will be possible on the day.

Any additional instructions will be issued with the confirmation of entry and numbers, to be posted not later than 28th July 2009.

**Notes for Exhibitors: GENERAL CONDITIONS**

All staff, judges, stockmen, stock owners and show personnel must comply with their obligation to 'enter and leave the licensed area clean'. It is a requirement that full details of any stock-handlers that will have had contact with your stock before arriving and at the show be provided **on the reverse of the entry form**. The society will provide facilities as required in the licence conditions.

All vehicles must be free of contamination (other than any contamination caused by animals inside the vehicle) when arriving at the show, and must remain in the licenced 'animal area' whilst at the show.

All show animals will have to be inspected by a veterinary surgeon on arrival at a showground before they mingle with other animals. **The Vet will be on-site from 7.30am to 9.30am, please ensure that you arrive between these times.**

**CATTLE / BCMS**

Cattle arriving at the show must be individually identified and pre-registered on the entry form.

All cattle must be accompanied by either a chequebook-style passport (CPP13) a Certificate of Registration (CHR3) or Certificate of Registration and blue/green passport (CPP1). Owners will be responsible for reporting the 'movement off' their own holding on show morning.

The stewards will stamp the 'on / off' or 'market movement' section and sign the passports on arrival at the showfield. The Secretary will report the movements to and from the showfield by returning the movement section of the passports directly to BCMS as soon as possible. Owners will be responsible for reporting the 'movement on' to their holding when the cattle return.

**SHEEP / MV ACCREDITED STOCK**

Sheep tag numbers to be provided on the AML1 Movement licence for the stock to move to the showfield. The Stewards will have a supply of blank AML1 Licences for the movement of sheep back to the home holding – however, it would save time on the field if exhibitors could supply partly completed forms for this return movement ready for signature on the day. The showfield address is Cartmel Park, Cartmel, Grange over Sands, LA11 6QF and the holding number is 08/640/8000. All MV accredited stock must be accompanied by a current, valid Green SAC certificate of accreditation. These certificates will be forwarded to the SGHS by the Society Secretary immediately after the event.
